


# Scottish Out of School Care Network Annual Review 2023-2024



# The Scottish Out of School Care Network

Established in 1991, we provide a voice for school age childcare services and the children and families who rely on it. We influence national policies and provide a range of practical resources, events, information, advice, quality assurance and training to support them. We advocate for the sector, carry out research, and help develop national and local strategies to support and grow the sector. We are passionate about children's rights to the play, care, learning, friendship and fun that good quality services provide.

# School Age Childcare

The school age care childcare sector is the largest provider of play, care, and informal learning opportunities for school-aged children. There are 904 OSC services in Scotland; 682 where OSC is their main service, and 222 additional services providing OSC (Care Inspectorate Dec 2022)

Daycare of children is defined by the Public Services Reform (Scotland) Act 2010 as a service that provides care for children on non-domestic premises for a total of more than two hours a day and on at least six days per year.

# Objectives and Activities

The objects of the charity are the advancement of the education and social welfare of children, by the development of daycare and recreational facilities for children. This is all school age childcare services, after school childcare, breakfast clubs and all-day care during school holidays.

We are committed to the UN Convention on the Rights of the Child (1989), equality and inclusion, in particular Articles 31; the right to culture leisure, rest and play; Article 12, the right to consultation and Article 18; state parties to develop appropriate services to support families, including assistance with childcare for working parents. We also have a particular focus on children in need or in poverty (Article 22) and support the provision of care for children with disabilities (article 23). We are also committed to promoting and delivering the outcomes of Getting It Right for Every Child (GIRFEC).

# Chairperson's report

This has been an exciting year as the Board decided to expand the small team in order to offer more practice support and training to the sector, as well as addressing the future sustainability of the organisation.

We welcomed Patrick Morrison into the post of Practice and Training Officer in September 2023, and, as you will see later in the training and practice support section, he has hit the ground running and is already proving to be a valuable member of the team.

I would like to thank Ann McKenzie from OPFS who gave many years of service to us, especially as treasurer, and in her work in supporting service development, and we all wish her well in her retirement.

# Policy representation and engagement

#### Ministers and Parliament meetings

We met the Minister for Children and Young People and Keeping the Promise, Natalie Don, MSP, at the Scottish Parliament in early June 2023 to discuss ongoing workforce and sustainability issues within the school age childcare sector.

Our Chief Executive gave evidence from our Parent and Carer Unmet Need for School Age Childcare Survey at the Scottish Parliament Social Justice and Social Security Committee - Inquiry into Child Poverty and Parental Employment on 25th May 2023.

Our Policy & Research Manager contributed to a Cabinet Minister for Education led anti-poverty round table summit in June 2023 and also attends the quarterly meetings of the Parliamentary Cross Party Group on Children and Young People. We met with Meghan Gallacher MSP, Chair of Parliamentary Cross Party Group on Children and Young People, later in the year to discuss school age childcare issues.

#### Scottish COVID-19 Inquiry

We met with Umara Rashid, a lawyer with the COVID-19 inquiry, seeking our evidence in terms of how COVID-19 affected SAC services and the impact it had on children and families. We submitted a formal statement and over 35 items of evidence to the official Scottish COVID-19 Inquiry. We also arranged for a number of school age childcare service managers to submit their own oral evidence to the inquiry.

#### Representation and engagement

We engaged with the UK Department of Work and Pensions regional managers across Scotland in over eight meetings and calls to arrange their input to helping parents with the costs of childcare.

### **Scottish Government and Statutory bodies**

We attended over 35 engagement meeting with Scottish Government officials, including 18 meeting with the Scottish Government school age childcare team. We had 20 meetings with the Care Inspectorate and 13 with the Scottish Social Services Council (SSSC). We have been instrumental in developing the revised Common Core Skills and Knowledge for the Children's Workforce, and managed the delivery and analysis of a feedback survey on the draft within tight timescales when no other organisation was able to do so. Our extensive work on qualifications is to ensure that the needs of school age children are considered, and our work ensure school age childcare staff see their roles reflected in regulatory guidance and practice documents.

We also engaged with local development staff, other national partner organisations, and individual experts to plan joint work and content of publications. We also hosted a 4 Nations UK-wide meeting with partner school age childcare support organisations in England, Wales, and Northern Ireland, to share developments across the UK. We will be exploring the differences in regulation in the future.

5 in-person sessions held across the country and delivered by SOSCN's new Practice and Training Officer, Patrick Morrison.

#### Summer, Easter, and October Holiday Football Coaching

Greig delivered 12 football coaching sessions directly to children in school age childcare services.

#### **New Practice and Training Officer Post**

The Board and senior staff team worked on a development and strategic plan in early summer to deliver more practical support to the sector, and to increase our sustainability. We advertised and recruited for a new post of Practice and Training Officer over summer 2023. Given that we have only three full-time and one very part time staff, we recognised we needed to increase our capacity and bring in new skills to develop new resources.

We appointed Patrick Morrison to the post in September 2023. Following an intense induction period which included surveying the sector on staff training needs, as well as looking at good practice, he has developed a delivered a range of useful resources and training courses, both in person and online.

#### **Online Training Platform**

SOSCN developed a new online training platform that was launched in March 2024. The platform aims to develop or refresh your understanding and enhance your skills in a range of subjects that you can put into practice, to help you deliver the best play and wellbeing outcomes for the children in your services.

# **Online Shop**

An online shop was developed and was launched in March 2024 with a range of toolkits and sample policies and procedures, all tailored for the school age childcare sector.

#### **Practice Focus Features**

A new feature that focusses on best practice in specific topics was developed by Patrick. Patrick visits services and interviews them while taking photos or short films to illustrate best practice, and moreover, how this related to Care Inspectorate inspections.

# Achieving Quality Scotland

This is our Quality Improvement Framework resource which is designed to help services improve their practice by requiring them to produce evidence to meet a set of quality standards. To help them do this we provide mentoring and training over the course of the two years they have to complete the process. This is paid-for work and Glasgow City Council purchased it for a group of Glasgow services pre pandemic; this was restarted last year.

We have held six mentoring sessions with the services working towards Achieving Quality Scotland, and this includes the UNCRC, and Getting it Right for Every Child.

# Online developments and social media

The website received over 7,500 users with over 10,400 sessions.

Our Facebook increased from 1,500 to 1,583 followers.

X (formally known as Twitter) now has 2,283 followers.

We sent out over 50 information emails including Bumper newsletters for Summer 2023, Winter 2023 and Spring 2024.


