The work of SOSCN in April 2019 to March 2020 was characterised by an energetic development of new and expanded training programmes, events and quality improvement work with the out of school care sector.



We had a fully booked up conference to celebrate out of school care planned for 23rd March, with short films with children, a great line up of speakers and workshops, including the Minister for Children and Young People, Maree Todd, but we postponed this and moved forward to June 2021 – for now to wait and see, if this is possible.

Undoubtedly, the middle of March 2020 will be remembered as the time so many organisations had to turn virtual, and for SOSCN, central to this is our communications and social media work, which has proved invaluable in still being able to deliver support, information and advice and to be policy advocates for the school age childcare sector.


Thanks to everyone

Who We Are

The Scottish Out of School Care Network (SOSCN) is the national infrastructure umbrella organisation providing support, mentoring, training, information and resources to all childcare services in Scotland, which provide childcare, play and learning opportunities for school-age children.

The formal objects of the charity are the advancement of the education and social welfare of children by the development of daycare and recreational facilities for children. This includes out of school care services and clubs, holiday care and breakfast clubs for school age children in Scotland.

These objects are underpinned by a commitment to the UN Convention on the Rights of the Child, 1989, (UNCRC) equality and social inclusion. The charity aims to promote the UNCRC at all levels of our support to school age childcare.

What is Out of School Care?

The out of school care sector is the largest provider of play, care and informal learning opportunities for school-aged children.

There are 1,014 Out of School Services in Scotland, for 748 this is their main service.

There are 661 breakfast clubs and 472 holiday services.

The number of children registered with main service OSC is 53,600. (Care Inspectorate, 2019)

Policy Development

We have worked in partnership with the Scottish Government team of civil servants appointed in this period to take forward the development of a new policy framework for out of school care.

New National Strategic Framework for Out of School Care

The Scottish Government Consultation on the Framework for Out of School Care launched in late summer 2019. A new £3 million Access to Childcare grant programme for out of school care for lower income families and children was launched in June 2019 for 2020/22. Both policy developments are mentioned in the Scottish Programme for Government 2020.

The consultation on the draft Framework for Out of School Care closed in early December 2019. As well as responding ourselves, we disseminated information on this frequently and social media images of children's views on out of school care collated by services. Over 1,200 responses were received, as well as further feedback from children and parents.

North Ayrshire Consultancy

In 2019/2020 we were commissioned by North Ayrshire Council to conduct a research and support consultancy project to measure the support needed by out of school care services and potential models of future delivery, including the creation of a local authority out of school care policy and establishing a local network. The final report was submitted in June 2019.

As a result of this work we produced a basic Getting it Right for Out of School Care Toolkit to help services cover all they need to do to be complaint with regulations and basic good practice.

New Physical Activity training online module

We completed, in partnership with CALA, an e-module on our physical activity training which was launched on the 7th January 2020. Participants taking this short online course grew to over 300 by March 2020. This was, in hindsight, a timely launch, as many of the March participants got involved at the beginning of the lockdown in the country due to COVID-19.



Regional Engagement events

We delivered 5 regional consultation events on the draft framework, in partnership with the OSC team at the Scottish Government. This was compressed over and intense two weeks to engage with the sector in advance of the closing date for responses. We would like to thank COSLA, Glasgow City Council, and Aberdeen Coty Council for their support with these events.

International Work

We continue to liaise with international contacts in our field and to share international research on our website and with colleagues. We also re-established our connections with the American National After School Association and met with them in Scotland in June as part of a study visit.

Achieving Quality Scotland (AQS)

In 2019 to 2020 there have been 10 AQS awards. We delivered 12 mentoring sessions, 10 to Glasgow services and 2 to Scottish Borders services.

Most services which have been inspected whilst undertaking, or having completed the process, have had their grades either go up or be maintained at 'very good' or 'excellent' levels.

Communications

We have produced 8 newsletters, 11 blog posts, responded to 4 consultations, and placed 36 recruitment adverts on our website.

We also sent out 12 membership email updates in between newsletters for important information sharing. For the last two weeks in March 2020 there was a daily email update covering COVID-19 and lockdown issues.

We also offered advice and support via email, telephone and in person to staff from services on a range of issues, including management issues, child protection, employment law and inclusive practice.

Social Media and Website

We had 2016 Twitter followers; 509 Tweets; 4,480 Profile views; 175 New Followers; 279,177 Total Impressions; and 392 Mentions.

We also had nearly 1,000 followers on Facebook.

We had 7,370 users visit our website and 20,903 page views.
